## Curriculum

The Masters is delivered through three 60 credit blocks. Each block represents c 70 hours of taught content, normally within 2-hour sessions. The first two blocks are each divided into 4 x 15 credit Modules. Four Modules are taught in each 10-week term, with one Reflection week per term. The third 60 credit block will usually comprise the student undertaking training in a research dissertation, based on individual and professional interest.

Each teaching session includes lecture, seminar and interactive workshop elements. You will usually have one formal summative assessment at the end of each Module.

### Global Human Resource Management Practice and Organisational Behaviour

The module develops functional knowledge and critical understanding of key perspectives on human behaviour in the workplace. It focuses on processes of organising, leading, planning and managing human activity, in business settings. The module considers core organisational HRM policy and practice.

### Leading with Purpose

This module equips students with the knowledge and skills to lead organizations with purpose, aligning leadership strategies with organisation values, ethics, and societal impact. Through theory and practice, students will understand how to mobilize teams towards meaningful and sustainable goals.

### Strategic Management

This module provides an opportunity to reflect on contemporary issues surrounding strategic management. Through critical insight and outlook, the topics will enable an understanding and critical examination of current and relevant challenges faced by organizations.

### International Marketing in the Digital Age

The module provides an overview of international marketing strategies and practices, that businesses face when operating in the global marketplace. Students will learn to develop, implement, and manage marketing strategies related to international trade, cultural differences, and global market trends.

### Principles of International Project Management

This module offers a comprehensive overview of project management principles, emphasising their application in international and large-scale contexts. Key topics include the project lifecycle, covering planning, resource allocation, risk management, and stakeholder engagement.

### Project Management Execution and Implementation in a Global Environment

In today's fast-changing global business environment, organisations face immense pressure to adapt, innovate, and compete. This module is designed to develop students' critical thinking and decision-making abilities by exploring the strategic and project management approaches needed for success in varying cultural and national contexts.

### International Project Management Practice

This module provides a comprehensive overview of project management for managing diverse and complex projects. Key topics include project design, planning, budgeting, international financial and contractual management, and quality and change control.

### Project Management in the Digital Era

This module focuses on equipping students with practical skills and theoretical knowledge essential for managing digital transformation projects effectively in modern organisation settings. It emphasises the critical role of technology and IT in contemporary project management, exploring emerging technologies and essential IT competencies. Students will gain insights into how these tools can be applied to enhance project outcomes in today's dynamic, technology-driven environments.

### Consultancy Project or a Research Dissertation

Drawing upon the skills and knowledge developed in the first two semesters, students will complete either a Consultancy Project or a Research Dissertation. Preparation for the Project starts at the outset of the programme, during the induction activities. Students will be expected to draw on their own work experience and, if possible, their own relationships with employers or former employers to discuss and develop their Research Projects.
